NOTE: Many family trees give Mary Wright as John Tatum's wife; however, this is incorrect. The John Tatum who married Mary Wright was a different man, as documented by data at the website of the Daughters of the American Revolution, [www.dar.org](http://www.dar.org).

Interestingly, handwritten notes about family history by a descendant's (Dianne Doyle Stephens) deceased father say that this John Tatum and his brother Jesse fought in the American Revolutionary war. John died too early to have applied for a pension. The original war records burned about 1800.

Lumpkin County, GA records show deed from Sheriff Samuel King to Hugh Tatum,1836. Lot #303 in lower half of 12th Distinct and first section.\_

Dawson County, GA records show on 2-8-1862 that Hugh Tatum sold 115 acres for \$507.00 to Thomas Roland. Lots #410-11 and a part of lot #368 in 13th District and first section. I William Tatum being sick and low but sound and disposing mind do hereby make constitute and ordain this is my last will and testament. Item first after all must just debts and fureral charges are paid I do bequeth all the remainder of my property as follows, to wit: Item second all my real and personal property to my wife Rebecca during her natural life or widowhood with an exception of three beds and furniture which is now claimed by my three daughters Oma (This is Neoma), Martha and Eliza and it being my wish that they should keep and hold the same. I furthermore bequeth to my above named daughters Oma Martha and Eliza to each one cow and calf. It is futhermore my wish that my executors or administrators shall sell to satisfy my debts such property as he or they in their good judgement may see the family can best do without. It is further my wish that after the death or remarriage of my wife Rebecca that all my property ezcept those items above excepted be sold and equally devided between my eight children: Jesse M Tatum, Parthenia Pace, Sarah Boozer, Oma Tatum, Alpha Boozer, Rebecca A Anderson, Martha C Tatum, Eliza A Tatum, with an exception on one hundred dollars that I William Tatum paid for Isaac Pace, husband of Parthenia Pace, and the condition of the above is such should Isaac Pace account to my executors for one hundred dollars with interest, he is then to have an equal share with the balance codicil. Should my wife Rebecca marry she is then to have a childs part of all my property, and I do hereby constitute and appoint to execute the above my son Jesse M Tatum and Oliver P Anderson. I have hereunder set my hand seal the day and date above written in the presents of Thomas D Pearson, William X Tatum, Unk Wilson. Albert Alexander, Justice of the Peace.\_He died on July 29. The will was recorded 11 Sep 1850 in book 14, page 188. The Court House burned down, but a copy was available. Census, 1850, Benton County, AL, he was listed as 67 and Rebecca was 56. It is not known when he moved to Alabama or if he stoppen on the way. 1820 census he was in the Pendleton SC, District. 1840 census he was in Benton County, AL. The 1850 and 1860 censuses show her as younger, but vary widely -- 1800 in the first one and 1810 in the second.

There are references in family trees for Mary Tatum, who married Sheriff Haynes, that her grandparents were buried near her in Bethlehem Methodist Church cemetery (the church is now Bethel Community Church). The source of the information about burial was Mary's death notice (possibly in the Keowee Courier). Note from C.G.: I could not locate any 1884 copies of this newspaper. Many assume that Mary's parents were buried there, also. There are no surviving Tatum headstones today or a surviving headstone for Mary Tatum Sheriff. The family trees (found on www.Rootsweb.Ancestry.com, WorldConnect Project) say that at one time there seemed to be markings of graves at the foot of the lot for Mary's son Harper Haynes, who was buried there years later. I could not locate anyone to query about this when I did a search.
